1.	Prior to commencing construction of the project the Developer's contractor shall submit to EHRWSD, in triplicate, copies of all necessary shop drawings for material to be used on the project. If approved by EHRWSD, one copy will be returned to the contractor, one copy used for inspection, and the remaining copy for EHRWSD records.
2.	A representative of EHRWSD must inspect all construction work on a continuous basis. The Developer shall reimburse EHRWSD for the cost of inspection.
3.	Any and all changes that may be required during construction shall be agreed upon in writing by EHRWSD, the Developer, and the contractor prior to making changes.
4.	All necessary county or state highway permits shall be the responsibility of the Developer and copies of same must be provided to EHRWSD prior to the start of construction.
5.	Prior to the start of construction, the installing contractor shall submit to EHRWSD, proof of insurance coverage for liability & property damage in the amounts required by the project specifications, as approved by EHRWSD. The contractor shall also submit a valid State of Ohio, Bureau of Workers' Compensation certificate to EHRWSD.
CONDI	TIONS FOR FINAL ACCEPTANCE & PLACING IN SERVICE:
1.	The new water main extension shall be certified by the inspector to be complete, and ready for service, in accordance with the plans and specifications approved by EHRWSD.
2.	All inspection fees and any other fees relating to this project must be paid in full.
3.	The Developer shall provide EHRWSD with an affidavit that all materials and labor for the project have been paid in full.
4.	The Developer must provide EHRWSD with a certified cost of the project.
5.	The Developer must provide EHRWSD with a maintenance bond in the amount of 10% of the certified cost of the project.
6.	The Developer shall provide EHRWSD with the executed "Notice of Substantial Completion" covering all materials and workmanship for a period of one year. The Developer and EHRWSD shall mutually agree on the procedures for making any necessary repairs during the warranty period.
7.	Upon acceptance of the extension by EHRWSD, all lines, equipment, etc. (including income to be generated there from) shall become the property of EHRWSD; EHRWSD's reimbursement policy relative to future connections by adjoining property owners, may apply. No connection to EHRWSD's system will be allowed, and no extensions will be accepted by EHRWSD, without advance approval.
