IV. FIRE PROTECTION SERVICE CONNECTION CHARGES

Buildings provided with a separate fire service line shall be charged a fire meter charge (d), a fire tap charge (e) and a capacity surcharge (f) in addition to the tap charge (a), meter charge (b) and capacity charge (c) for a water service.
